## WE tv Insiders SWEEPSTAKES RULES & REGULATIONS

## NO PURCHASE NECESSARY TO ENTER OR WIN

- **1. SWEEPSTAKES PERIOD**: This Sweepstakes starts on January 1, 2017 and closes on December 31, 2017 at 11:59 PM Eastern Time. The Sweepstakes is sponsored by WE tv LLC (WE tv or the "Sponsor"). The Sponsor is and shall remain solely responsible for the delivery of the Prize(s) to the winner(s).
- **2. ELIGIBILITY**: This Sweepstakes is open to all registered members of the WE tv Insiders Panel ("**Entrants**"). All Entrants must be individuals legally residing in the United States. Sponsor reserves the right to require proof of residence prior to awarding any prize. If a minor is selected, the prize will be issued in the parent or legal guardian's name.
